(Revenue \$) EDUCATION ASSISTANCE - THE GENERAL HENRY "HAP" ARNOLD EDUCATION GRANT PROGRAM PROVIDES NEEDS-BASED EDUCATION GRANTS TO CHILDREN AND SPOUSES OF AIRMEN. IN 2016, THE SOCIETY AWARDED ALMOST \$6 MILLION IN GRANTS TO 2,332 STUDENTS TO HELP PAY FOR COLLEGE. AN ADDITIONAL 51 STUDENTS RECEIVED MERIT-BASED SCHOLARSHIPS, TOTALING \$111,000, WHICH ARE DESIGNED TO REWARD THE HIGHEST ACHIEVING INCOMING FRESHMEN. SCHOLARSHIP SELECTION IS BASED ON A STUDENT'S GPA AND A WRITTEN ESSAY. IN ADDITION TO GRANTS, THE SOCIETY ALSO PROVIDES UP TO \$1,000 IN INTEREST-FREE LOANS TO HELP DEFRAY SOME OF THE ADDITIONAL COSTS FOR SCHOOL BOOKS AND SUPPLIES. IN 2016, \$54,000 IN NO-INTEREST LOANS WERE ISSUED.

EMERGENCY ASSISTANCE (EA) - THE EA PROGRAM IS PRIORITY NUMBER ONE FOR THE SOCIETY AND IS AIMED TOWARDS HELPING RELIEVE THE FINANCIAL PRESSURES ON AIRMEN AND THEIR FAMILIES BY ASSISTING WITH IMMEDIATE FINANCIAL NEEDS IN AN EMERGENCY SITUATION. SUPPORT IS PROVIDED THROUGH INTEREST-FREE LOANS AND GRANTS, DEPENDING ON THE INDIVIDUAL CIRCUMSTANCES SURROUNDING THE NEED. EA IS PROVIDED FOR BASIC LIVING EXPENSES, EMERGENCY TRAVEL, VEHICLE REPAIRS, FUNERAL COSTS, MEDICAL/DENTAL COSTS, CHILD/RESPITE CARE, AND MOVING EXPENSES. AIR FORCE FAMILIES CAN ALSO RECEIVE HELP DEVELOPING A FAMILY BUDGET IN AN EFFORT TO STAY ON TOP OF THEIR FINANCES AFTER THE ASSISTANCE IS PROVIDED. IN 2016, \$6 MILLION IN NO-INTEREST LOANS AND \$1.5 MILLION IN GRANTS WERE PAID OUT TO HELP ALMOST 14,000 AIRMEN.

FUNDING FOR CHILDCARE PROGRAMS WAS \$681K IN 2016, AS OVER 16,700 CHILDREN WERE CARED FOR THROUGH THE GIVE PARENTS A BREAK, CHILDCARE FOR PCS, AND CHILDCARE FOR VOLUNTEERS PROGRAMS. BUNDLES FOR BABIES PROVIDES EXPECTING FAMILIES INFORMATION ON BUDGETING FOR THE IMPACT OF A NEW BABY WHILE PROVIDING RESOURCES TO ASSIST ALONG THE WAY. IN 2016, THE BUNDLES PROGRAM SPENT \$116K TO PROVIDE INCENTIVES FOR THE FAMILIES THAT ATTENDED THE COURSE. THE SPOUSE EMPLOYMENT PROGRAM PROVIDED ENTRY-LEVEL TRAINING TO OVER 750 SPOUSES DURING THE YEAR, SPENDING \$250K. OTHER PROGRAMS FUNDED BY THE SOCIETY IN 2016 WERE THE CAR CARE, PHONE HOME, AND HEART LINK PROGRAMS.
